Eligibility Requirements:

1. High school senior or an undergraduate student.
2. Plans to be a full-time student for the upcoming school year in an undergraduate degree program by an accredited college or university, or enrolled in a vocational or technical school.
3. A dependent child of an employee of a member of the National Propane Gas Association. The parent's work must be directly related to the propane industry. (When an affiliated state or regional association is a Platinum Donor, the employer must also be a member of that association for the applicant to be eligible for that state's award)

Entry Requirements:

1. An official application form (submitted online only)
2. Two completed evaluation letters (submitted directly by the evaluator by email only to tfalls@npga.org)
 - a. E-1 Evaluation letter must be submitted by email only by an adult not related to you nor by any faculty members.
 - b. E-2 Evaluation letter must be submitted by email only by any current or former faculty member.
3. Official transcripts of all high school and college records (first semester students need only to send high school transcripts and college transcripts if dual-enrolled) may be submitted by email, fax, or mail to NPGF Scholarship Program 1150 17th Street, N.W., Suite 310, Washington, DC 20036, fax 202/466-7205.
4. Authorization to release family financial information (Located on the last page of the online application).
