- Carburetion Installer** – Engaged in the installation of propane carburetion equipment on vehicles **(Supplier 2)**
- Container Manufacturer** – Engaged in the manufacture, assembly and marketing of propane containers (tanks and cylinders) **(Supplier 1)**
- Equipment Manufacturer** – Engaged in the manufacture, assembly and marketing of equipment designed for use with the utilization of propane, including manufacturers and assemblers of components becoming part of such equipment **(Supplier 1)**
- Insurance Carrier or Underwriter or Insurance Agency (Services Section Membership)** – Provides insurance coverage to the propane industry and supports the purposes of the Association **(Carriers/Underwriters, Supplier 1) (Agencies, Supplier 2)**
- Manufacturer’s Representative** – Independent wholesale sales representative for one or more of the manufacturers described above who neither warehouses such products nor invoices for their sale **(Supplier 2)**
- Transporter and/or Storage of LP-gas** – Engaged in the for-hire transportation of propane with published tariffs on file with the state or federal regulatory agencies, or engaged in the for-hire bulk storage of propane **(Storage/Pipeline Transporter, Supplier 1) (Truck Transporter, Supplier 2)**
- Vehicle Fabricator** – Engaged in the fabrication of vehicles used in the distribution of propane and its containers **(Supplier 2)**
- Wholesale Distributor of Appliances, Containers, Equipment** – Engaged in the wholesale marketing of appliances, equipment or containers designed for use with propane **(Supplier 2)**
- Producer/Non-producing Broker/Wholesaler of Propane** – Engaged in the production of liquid hydrocarbons or engaged in volume sales of such products for resale. **Number of states into which a company supplies product**
